### Rules and Pertinent Information:

- A dependent is defined as a child of the member under the age of 18 living at home or a full-time college student under the age of 23.
- Fees are not guaranteed and are subject to change, without notice, at the discretion of management.
- Members who resign their membership and decide to return may be assessed a new full initiation fee at the current prevailing rate.
- Leaves of absence will be reviewed and granted by management on a case-by-case basis.
- Leaves of absence granted: If returning as a member within a 12-month period, member will be responsible for all months' dues during absence.
- Proper Attire, including suitable footwear, must be worn at all times by members and guests while on the golf course and/or practice areas. Shirts without collars (for men, except logo golf shirts) and tank top shirts (for men and women) are not permitted. Denim pants or shorts (jeans or jean shorts, any color) are not permitted during the Golf Season. **Maple Creek is a non-metal spike golf club.** We ask you to make sure that you and your guests have non-metal spikes on your shoes before you arrive to play. Your cooperation is essential. Members are responsible for their guests being properly attired. Management has the option of denying golf registration or to refuse service to anyone improperly attired.

I/We agree to pay all dues and charges incurred against my/our account on a timely basis and acknowledge the fact that if my/our account becomes delinquent then interest charges will be applied. I/We further agree that charges not paid by the 10th of the following month will be charged to the credit card on file, along with a 5% late fee and that I/We would be fully responsible for any fees and/or court costs associated with the collection of my/our just debts to the Club.

I/We understand that resignation must be submitted in writing by me/us in order to terminate the membership. The effective termination date will be the last day of the month the letter is received at the Club.

I/We understand that the Club shall have the right to terminate my/our membership if, in their opinion, I/We have abused privileges of membership, caused unwarranted damage to any property or facilities, or conducted myself/ourselves in a manner detrimental to the best interest of the Club, or at the Club's discretion.
